

BOATS RENTAL CONTRACT

(print and keep it)

Please note that we are a French registered company and our contract is regulated by French law and will be considered to have been made in France. Any proceedings arising out of or in connection with this Contract may be brought in any court of competent French jurisdiction.

« DES AILES SUR LA VAGUE » manages and rents the boats.
The boats are rented docked and shipping is not allowed.

DEPOSIT

30% of the rent is paid when booking, except for overnight stays booking. Overnight stays will be paid at one time.

The booked period is reserved during 10 days. After these 10 days, if deposit is not received, the booked period will be canceled and could be rent to somebody else.

PAYMENT

Booking is effective when the tenant send back the booking document dated and signed with the deposit sum by cheque payable to "DES AILES SUR LA VAGUE". The payment will be completed by mail, at the latest 15 days before the first day of rent.

SECURITY DEPOSIT

A 250 € security deposit has to be sent in the same time than the deposit. This security deposit will be sent back to you by mail the month following the departure date.

RENTAL TERMS

The rental week commences on a Saturday at 5p.m and ends on a Saturday at 3p.m.

The overnight stay commences at 5p.m and ends at 3p.m.

Outside high season, please contact us if schedule adjustment is needed.

If you go over schedule, you will owe us an extra overnight stay, and if the boat is still busy at 8p.m the entire security deposit will be retained.

If some belongings or persons are still in on the boat, the following tenants will be rehoused by the previous tenants, that is to say a night in a hotel or bed & breakfast, without prejudice of the security deposit.

CANCELATION TERMS

Generally, deposit is non-refundable; nevertheless it will be reimbursed if the boat could be re-let for the same period and at the same price except during high season (see current calendar to check the high season dates). During high season, 10% of the total amount of the stay with a minimum of 20€ will be retained to re-let the boat.

In case of anticipated break of the rent by the tenant, and if the renter has no responsibility for it, there will be no reimbursement, except the deposit.

In case of break by the renter, the deposit will be reimbursed.

INVENTORY OF FIXTURES

The incoming inventory of fixtures is done by the tenant at the beginning of the stay. The tenant has to note and inform the renter of any damaging, missing or broken item of the inventory.

The outgoing inventory of fixtures will be done with the empowered person in presence of the tenant.

In case of anticipated departure of the tenant without contradictory inventory of fixtures, the latest could not contest this inventory.

Inside and outside cleaning will be done by the tenant.

COMBINATION LOCKS:

The code of the lock is given at the tenant at the arrival.

Only the entry combination has to be done on the lock. If this one does not work at the outgoing inventory fixtures, we will retain 25€ (fixed amount).

Moreover, the combination lock cannot be forced, changed or be a toy for children.

Regarding boats with a digital access code, a fixed amount of 120€ will be retained in case of damage or if the renter has to replace it because of bad handlings from the tenant.

IMPORTANT:

When you leave the boat, please take away your food, your drinks and your personal belongings; wash, wipe up and put the crockery in the boxes and clean the latter and the inside and outside of the boat.

We insist on this fact because the tenant does not know when the boat will be rented again and leaving leftovers can generate very bad smell in the boat.

If the previous conditions are not respected, we will retain a fixed amount of 50€ for non-respect of the contract.

Thank you for understanding.

If the conditions of the boat after your departure are not satisfactory, and that a new inventory fixtures has to be done we will retain a fixed amount of 20€.

Animals are allowed under the responsibility of their owners.

HOUSEHOLD LINEN

There is no sheet and towel (we rent some by request, please ask us)

TOILETS

Showers (charged) and toilets reserved to the amateur sailor, with a code, are accessible at 100 meters behind the Information Office.

SECURITY ON BOARD:

From your arrival on board of the boat you have to test the fire alarm pushing the button « test ». If it does not work please contact us immediately.
